Limited Review Report on the Unaudited Financial Results of the Company for the Quarter ended 30th June 2020, Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.

1. We have reviewed the accompanying statement of Unaudited Financial Results of **BENGAL STEEL INDUSTRIES LIMITED** (the “Company”) for the quarter ended 30th June, 2020 (“the statement”) being submitted by the Company pursuant to the requirements of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“Listing regulations”). This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.
2. We conducted our review of the statement in accordance with the Standard on Review Engagement (SRE) 2410, “Review of Interim Financial Information performed by the Independent Auditor of the entity”, issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
3. Based on our review conducted as above, nothing has come to our notice that causes us to believe that the accompanying statement of Unaudited Financial Results prepared in accordance with the applicable Indian Accounting Standards (Ind-AS) and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended including the manner in which it is to disclosed, or that it contains any material misstatement.



Emphasis of Matter

4. Without qualifying our opinion, we draw attention to the following:

- a. Attention is drawn to Note No. 2 of the financial statements, as regards the Managements evaluation of COVID 19 impact on the future performance of the company.
- b. Income Tax advance of Rs. 68,20,302/- remains unadjusted.
- c. Book balance of Rs. 18,506.21 with UCO bank, Rs. 30,471.80 with HDFC Bank, Rs. 1,45,762.45 with UBI and Rs. 59,939.19 with Bank of India could not be confirmed.
- d. Non recognition of Impairment loss.
